Did You Know?

EU regulations stipulate that any insured person in an EU country can receive necessary health care services in another EU country. Persons insured in an EU country can receive planned health care services while traveling to another EU member state by using the S2 form issued in the country of insurance or by receiving planned health care services without prior authorization and paying for them out of pocket, with the possibility of claiming reimbursement later.

What to Consider:

- Services can be obtained from both public and private providers.
- The service must be fully paid out of personal funds.
- Reimbursement is possible only for services that are funded by the state budget in the country of insurance.
- Expenses are reimbursed according to the tariffs applicable in the country of insurance, which may differ from the amount paid.
- Before receiving the service, you can contact the NHS to inquire whether the service is funded by the state budget and what the applicable tariff is in the country of insurance.
